

Regulations of www.listenforsyria.com

An agreement between the Benefactor and Foundation can be concluded in one of two ways. Prior to making its donation the Benefactor has the right to negotiate all provisions of the agreement with the Foundation, including amendments to these Regulations. These negotiations should be conducted in writing and sent to our mailing address (Polska Akcja Humanitarna, ul. Szpitalna 5/3, 00-031 Warszawa). If the Benefactor decides not conclude the agreement by way of individual negotiations, the following regulations and the law in force shall apply.

REGULATIONS

2. Any natural person of age, any legal person or any organisation unit without legal personality may be a **Benefactor**, hereinafter “**Benefactor**”.

3. Donations can be made at any time.

4. The agreement is concluded the moment the Benefactor makes a donation. A donation made by wire transfer is deemed completed after the Benefactor’s donation is credited to the Foundation’s bank account.

In the case of payments made by card the moment of positive authorisation counts as the moment of donation.

Benefactors can make donations in the following way:

a) wire transfer – payment is made by wire transfer to the Foundation’s bank account:

b) payment card – Visa, Visa Electron, MasterCard, Maestro, MasterCard Electronic,

c) eTransfer – Pay with Inteligo, eurobank online payments, Pay with ING, mTransfer, MultiTransfer, Pay with Nordea, Przelewy24, BPH transfer, Crédit Agricole online transfer, Pay with iPKO, Pekao24Przelew, Pay with Citi Handlowy, PayWay Toyota Bank, MeritumBank transfer, Pay with BOŚ, Pay with Alior Bankiem, Millennium, Deutsche Bank Polska S.A., Bank Pocztowy, BS Wschowa, Invest Bank S.A., Kredyt Bank S.A., Raiffeisen Bank Polska S.A.

Payments made by payment card or by eTransfer are handled by eCard S.A.

5. The goods purchased, together with the sales document selected by the **Benefactor** (*invoice/receipt*), will be sent by the carrier selected by the **Benefactor** to the address entered by the Benefactor on the order form. The shipping methods and their costs are defined by the **Foundation**.

9. **The Foundation** undertakes to protect the personal data in accordance with the personal data protection act dated 29.08.1997 r (Polish Journal of Laws Dz. U. no. 133 item 883) and the act on electronic provision of services (Polish Journal of Laws Dz. U. no. 144 item 1204). When making a donation the **Benefactor** provides the **Foundation** with its personal data and agrees to the processing of the said personal data for the purposes of receiving marketing offers from the **Foundation**. The **Benefactor** may view, correct, update, and delete its personal data at any time.

10. None of these regulations is intended to violate the **Benefactor's** rights. They shall not be construed as such either, since in case of any inconsistency of any of these regulations with the law in force the **Foundation** declares that it will abide by and apply such law in place of the challenged provision of these regulations.

The **Foundation** ensures that www.listenforsyria.com will be displayed correctly in the following browsers: IE 7 or newer, FireFox 3 or newer, Opera 9 or newer, Chrome 10 or newer, Safari with the latest JAVA and FLASH version installed, on screens with the horizontal resolution greater than 1024 px. Using third-party software that affects the operation and features of the following browsers: Internet Explorer, FireFox, Opera, Chrome, Safari may also have an effect on the way the website is displayed and therefore, in order to ensure that all features of www.listenforsyria.com are available, such software should be disabled.

14. In matters unregulated by these regulations the law in force shall apply. Disputes shall be resolved by the court of competent jurisdiction.
